Course: YBA326 Anthropology of Ritual. ECTS credits: 3

Annotation: Studies of ritual continue to be of critical interest in anthropology. This course explores anthropological approaches to ritual as a universal feature of human social life. Attention will be given to key anthropological concepts of ritual (e.g. rites of passage, liminality, anti-structure, communitas, ritual as performance). Although ritual is sometimes considered as primarily related to religion, the anthropological approach requires that ritual be situated not only in religious but also in secular contexts, such as: politics and power relations, the construction of social identities and boundaries, the reproduction and invention of 'tradition' or social memory practices, globalization, commodification etc. We will also problematize the dichotomy of sacred and secular while discussing practices of today's individualized spirituality. Special focus will be paid to the negotiation of sound dimensions of ritual practice.
