# INDUSTRY AND EUROPEAN CULTURAL POLICY

## ■ Europe vs Nation vs People

- CP = means of promoting certain political or social values
  - enhancement of specific examples of heritage can contribute to the expression of different, and sometimes alternative, visions of European identity
- Use of heritage is not the privilege of the national governing center, the history-memory of which is ‘rivaled or contested in the name of partial, sectorial or particular memories (groups, associations, enterprises, communities, etc.), which all wish to be recognized as legitimate, equally legitimate, or even more legitimate.
- The use made by the MEPs (members of European Parliament) of the concepts of ‘industrial’ and ‘social’ heritage, which functioned as political resources, are a good illustration of this process of decentralization.

# INDUSTRY AND EUROPEAN CULTURAL POLICY

- Hahn report 1982 – first mentioning of INDUSTRIAL HERITAGE
  - not only rural and urban landscapes, but also the legacy of ‘industrial civilization’
- 14 March 1983 EP resolution : protection of Europe’s social heritage (socialists)
  - Social = architecture = archeology heritage
  - „*man's achievements in the social, industrial and rural spheres*“
  - „*what we have learnt from a century and a half of history of the world of labor in Europe*“
    - trade union movements and all the activities contributing to the progressive liberation of man through workers' and peasants' struggles
    - This profound transformation of society which has been achieved since the start of the 19th century is also part of our common heritage
  - the EP insisted on the symbolic dimension of the EC's participation in the revival of abandoned sites of industrial activities such as mines or metallurgical plants.
  - acknowledged that such places could indeed become symbols of what the EP called ‘Europe's social sphere’
  - Advocates of deeper integration in the social domain are keen to elevate certain places of the social imaginary in order to instill a certain interpretation of the Community's identity in the future.
- See European Regional Development Fund (since 1975)

# EUROPEAN REGIONAL DEVELOPMENT FUND (ERDF)

- Not a „cultural policy“ instrument initially - cohesion/regional policy
- support for regions affected by deindustrialization => conversion of former industrial sites
- In practice promoted „Europeanisation“ of industrial heritage
- UK
  - Conversion of Gwent Mine (Wales) into a museum
  - 416 000 ECU 1981



# INDUSTRY AND EUROPEAN CULTURAL POLICY

- Industrial Heritage finally recognized as European affair in 1990s
  - „no single event to shape the European landscape greater than the industrial revolution.“
- European Route of Industrial Heritage
  - BORN 1999
  - Initially GB, Belgium, Netherlands and Germany applied for funding within the framework of EU (Interreg IIC)
  - Duisburg Declaration 2001
  - The common history of European industry has played and will continue to play an important part in the culture and identity of our European nations and it offers possibilities to create both shared and individual identities.
  - The accessibility of our cultural heritage is a key element in experiencing this identity and it helps us to understand better our common roots.
  - The sustainable development of our industrial heritage helps to secure the economic and social regeneration of municipalities.
  - Historical continuity creates a sense of belonging and respect for the historical environment.
  - “The European Route of Industrial Heritage” is a project that underlines the importance of our shared industrial past.

- European Route of Industrial Heritage
- tourism information network of industrial heritage in Europe
- 1,315 sites in 45 European countries
- 90 Anchor Points which build the virtual ERIH main route
- 19 Regional Routes you can discover the industrial history of these landscapes in detail.
- All sites relate to 13 European Theme Routes which show the diversity of European industrial history and their common roots.

# ...BUT

- Initial Failure of ERIH to capture European dimension
- Selection strategies and interpretative frameworks show that:
  1. Transnational dimension of Industrialization suppressed
  2. Dark side of Industrialization overlooked
  3. National, not european locations–  
ERIH - „of Europe“ vs „in Europe“
- National sites, individual objects (disconnected)
- visionaries, entrepreneurs, inventors, peace, progress – what about war, environment, social conflict and deprivation?
- „Europeanness“ hardly a factor in selection

# PEENEMÜNDE

- ERIH
- Space technology anniversary 1992-1942
  - Werner von Braun
  - Protesty
  - V2 BOMBING
- rocket center
  - RaD Peenemünde
  - Testing site Poland
  - Kohnstein, Nordhausen – výroba (450 subs), POWs (Buchenwald)
    - 40 000 pows, 5000 army, 20 000 casualties
  - transnational military-industrial complex

- 1871, Röchling familie
- SAARSTAHLAG, 1986 closed
- 1994 UNESCO WHS
- Transnational military-industrial complex on the border fr/ger
- 1871 Alsace – divided
  - Dtto 1918
  - Resources location vs Industry location
  - Herman Röchling – protest after 1919, Nazi
    - After 1941 Nazi representative in chargé of french mines and steel industry
      - Closing of competitors in Alsace
    - POWs
    - Memorandum to Hitler – attack on the USSR, 1936
