Strong points

V. Enabling trade within the Union (also in case of restricted/closed borders) is essential to sustaining a stable economy during a pandemic rather than impairing it more by paralyzing the cross-border transport of goods. The Commission proposes enabling trade in future health crises through implementing green lanes following the <u>practical guidance to ensure</u> continuous flow of goods.
