ANO are the biggest cheerleaders and welcomers of migrants. The communist Konečná, on the other hand, is diligently dictating

Of course, this headline is an exaggeration. But only a little. YES in the Czech Republic and YES in the rest of the EU are two disjointed worlds. And the same applies to the leader of the coalition Enough! Kateřina Konečná. He preaches Anti-Brussels in the Czech Republic, and actively helps create it in Brussels.

Czechs have few certainties in life. One of them, however, is that someone will offer them protection from "Brussels" before the European elections. In 2019, it was Okamura's SPD, this time the role was taken up by the electoral coalition Enough! under the leadership of the communist Kateřina Konečná and the ANO movement.

Konečná looks down on the voters from the pre-election poster and next to her shines [the inscription "Brussels Dictatorship? Enough!"](#). Babiš's ANO then says on one of the slogans ["We are going to fight for the Czech Republic! Not to bow down to Brussels."](#)

Election campaigns are always a wilder period in politics and things are said that would not be heard in normal traffic. The ANO movement and the leader Enough! however, they are in direct opposition to themselves when we compare their current rhetoric at home and their actions so far in the EU.

The ANO movement in Europe is and wants to remain a member of the Euroliberals, who are by far the biggest "hoogers" in the European Parliament. The Renew faction declared EU federalization as its doctrine for the European elections, and of all the political groups it is the most loyal to the agreements that will be "baked" in Brussels. Its MEPs [vote in accordance with the pro-European majority](#) in up to 90% of cases .

While at Babiš's home people are scaring migrants in Czech villages, the Renew faction called [the adoption of the migration pact a victory](#) and a historic success for Europe. And if Andrej Babiš currently "wants peace", it is the Euroliberals who "want war" the most. [At the instigation of the Renew faction, the MEPs voted](#) not to approve the closing of the EU budget if the governments of the member countries do not deliver the promised Patriot air defense system to Ukraine.

And now the most important thing. MEPs for the ANO movement agree with the absolute majority of what the Renew faction defends. They voted against their group on the migration pact, [the departure from internal combustion engines in 2035](#) or the export of Ukrainian grain to the EU, where they defended the interests of their party leader.

However, it is a matter of individuality. In Europe, ANO representatives are part of the pro-European mainstream and behave completely differently from how Andrej Babiš portrays their role or the EU itself at home.

The same applies to Kateřina Konečná, who has been an MEP for ten years. From her election posters, it may look like she is just getting ready to go to parliament or that she is just holding up a red card there. Neither is true.

Konečná sits in the United European Left faction, which also voted in line with the pro-European majority in the vast majority of cases, and not "against Brussels". The Konečné faction is also the smallest of the seven groups in the

parliament, and thus has the smallest share of power. Representatives of this faction rarely manage to be rapporteurs for EU legislation.

Kateřina Konečná succeeded. Why? Because she wanted to, she actively asked for it. She was the rapporteur [for the directive on the protection of people when taking out consumer loans](#). She negotiated with other factions, debated with representatives of the member states and with the European Commission, and in 2022 she successfully completed the directive; Parliament approved it the following year.

In her words on the billboard, Konečná was and is part of the "dictation of Brussels" of her own free will, if by this term we understand the approval of laws and standards by institutions in Brussels and Strasbourg, which then also apply in the Czech Republic.

The "dictation of Brussels" is factually nonsense a priori, because the Czech Republic and its representatives sit in the EU as members from the beginning and in everything, so there can be no question of any dictation. In the case of the Renew MPs, representatives of the ANO movement, and Kateřina Konečná, it is about selling a false illusion. They do one thing and claim another. They are Jekylls and offer their Hyde to voters.
